RELAYING STORIES FROM THE GROUND: A TRANSFORMATIVE EXPERIENCE

Relaying stories from the ground through this newsletter has been more than an act of communication; it has been a journey of discovery, empathy, and empowerment. We've witnessed firsthand the struggles, hopes, and triumphs of communities facing significant challenges—and through sharing these narratives, we've built bridges of understanding and action.

Each story has been a testament to resilience and courage, reminding us of the importance of listening, learning, and amplifying voices that too often go unheard. It has been our privilege to serve as a conduit for these stories, and we remain committed to continuing this work with integrity and dedication.

The Impacts of Pipeline Installation on Kasinyi Village, Buliisa District

The residents of Kasinyi Village, located in Nile Parish, Ngwedo Subcounty, rely on small-scale farming and fishing on Lake Albert for income and food security. Crops such as maize, cassava, sweet potatoes, cowpeas, and watermelons have supported their livelihoods for generations.

Culturally, the community is home to diverse ethnic groups, including the Bagungu and Alur, who maintain a deep connection to the land and natural environment. However, the discovery of oil in the region has brought disruption, displacement, and environmental degradation.

The construction of the East African Crude Oil Pipeline (EACOP) has left families like that of Selina Ketehe facing devastating impacts. Flooding caused by water flowing from trenches for pipeline installation has submerged farmland, destroyed crops such as bananas, cassava, and watermelons, and blocked access to homes. Children face grave dangers of drowning due to the uncontrolled water flow.

Despite reaching out to TotalEnergies with their concerns, responses have been dismissive and lacked empathy. The community's demands include:

Immediate assessment of destroyed crops.

Relocation of homes near the pipeline to ensure safety.

Prioritization of meaningful community engagement to balance development with environmental and social well-being.

This pipeline threatens vital ecosystems, water sources, and livelihoods. Its construction has already led to forced evictions and inadequate compensation, leaving families without homes and means of survival.
